Show Rules and Regulations

Entries:

All Entries must be sent to **401 Kingsley Rd, Kingsley, NB, E3G 6C2** and received **no later than August 17th, 2015**. The show committee reserves the right to refuse any entry. **No Faxes or Emails accepted.**

Late Entries:

Entries accepted after the closing date of **August 17, 2015** will be subjected to a late fee of \$20.00.

Incomplete Entries:

Any entry that **does not include**: photocopies of equine flu/rhino & strangles vaccinations within the past 12 months, photocopies of 2015 NBEA membership for the competitor and owner, completed entry form and signed waiver, will be subjected to an incomplete entry fee of \$20.00. Numbers will not be issued until the entry is complete.

Memberships:

All riders and owners require a 2015 NBEA membership.

Dressage New Brunswick (\$20.00/year for new members)

Dressage New Brunswick is a non-profit organization affiliated with the **New Brunswick Equine Association**. Memberships run from January 1st to December 31st. Vaccinations:

All horses attending the competition require equine flu/rhino, strangles vaccinations within past 12 months

Refunds:

After closing date, refunds of 50% of entry fees (not including administration fee) will be awarded with veterinarian's certificate. There are no refunds after the start of the competition.

Ring Size:

All tests will be ridden in a 20m x 60m sand ring

Ring Numbers:

It is compulsory for the horse's competition number to be worn by the horse anywhere outside the stall from the time that the number is issued until the end of the competition so that officials can identify the horse.

Tests and Divisions:

The following dressage classes will be offered: Equine Canada Walk/Trot to First Level and will be divided into Senior and Junior categories.

“Every class offered herein is governed by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book.” Any situation requiring a ruling which cannot be referenced according to the Equine Canada and NBEA rules will be rendered by the Show Committee.

Ribbons:

Ribbons and awards for all classes will be awarded from 1st to 5th place. The award presentation will take place 10 minutes after the last ride of the day. **All competitors are required to be in full riding attire for this presentation.**

Awards:

A special award will be presented for each division (Walk/Trot, Training, First Level). This will be awarded to the horse and rider combination that receives the highest average score over 2 tests at the same level.

Ride Times:

The ride times will be available on Wednesday August 20th after 5 pm and will be emailed to all riders.

Stabling:

Limited stabling is available and needs to be arranged directly with Sarah King owner/operator of Pickett Hill Equestrian Centre 506-442-2299

From the Trans-Canada Highway (Route 2)

- Turn onto PROVINCIAL SECONDARY ROUTE 101 W (Regent Street) heading towards downtown Fredericton. Take the ramp toward FREDERICTON NORTH/FREDERICTON NORD.
- Turn SLIGHT RIGHT onto WESTMORLAND STREET BRIDGE.
- WESTMORLAND STREET BRIDGE becomes PROVINCIAL SECONDARY ROUTE 105 N.
- Take the ROYAL RD/CH ROYAL/HWY-620/RTE-620 ramp toward STANLEY/MAIN ST/RUE MAIN.
- Turn RIGHT onto ROYAL RD/HWY-620/CHEMIN ROYAL. Continue to follow ROYAL RD/HWY-620.
- Turn Left onto Kingsley Road
- Pickett Hill Equestrian Centre 50 Kingsley Road.
